CREATING A USER ACCOUNT

- Mandatory data:
 - e-mail address, title (Mr, Ms, Mrs, etc.), first name, last name
- Voluntary personal data: special title (e.g. Dr, Prof)

USING ONLINE SERVICES (STORED ITEMS)

 "Stored Items" is where the data entered by users when using online services – such as details of the companies they intend to visit during the fair – is collected and stored. Users can change or delete these data at any time.

REGISTERING COMPLIMENTARY ADMISSION TICKETS (TICKET REGISTRATION):

• Mandatory data:

e-mail address, title (Mr, Mrs, Ms, etc.), first name, last name, industry, job function, job title, postal address (street name, building number, postal code, city and state/country)

USING THE LEAD MANAGEMENT SERVICE

I hereby give my permission for the exhibitor to use this data for his or her present and future trade fair planning. I give my consent for my data to be used for advertising purposes in accordance with clause 4 of this Declaration of Consent.

4. USE OF PERSONAL DATA FOR ADVERTISING PURPOSES
